Estes Park Power and Communications, Fort Collins Utilities, Longmont Power & Communications, or Loveland Water and Power.

### Our team may install the following qualifying products\* in resident units and/or common areas:

- High efficiency LED lighting
- Energy efficient faucet aerators
- Energy efficient showerheads
- Smart thermostats

\* Actual products may differ from the images shown. Not all properties are eligible to receive free installation of high efficiency showerheads, faucet aerators, and/or smart thermostats. Efficiency Works will work with local municipalities to determine eligibility on a case by case basis.

# Efficiency Works rebates

Businesses that meet eligibility requirements may qualify for the rebates listed below. Contact the Efficiency Works program to receive your free energy assessment and identify your opportunities.

Custom rebates may be available for VFDs above 75 hp.

## Custom

Category	Rebate
Energy	\$0.10 per kWh (first year)
Summer peak demand	\$500 per kW
Water (Fort Collins only)	\$10 per 1,000 gallons/year saved

Summer peak hours are weekdays, June through August, between 3 and 6 P.M. Additional rules apply; see the current version of the rebate application for all restrictions.
