Additional requirements

1. Verify surge protector is appropriate for equipment and appliances that will be plugged in and will protect at lower power surges.
2. The electric incentive is available to eligible commercial electric customers. The water incentive is available to eligible water customers of Fort Collins Utilities, City of Longmont and Loveland Water and Power. Customers who are eligible for both the electric and water incentives can receive both incentives.
3. Portable or single burner induction cooktops are not eligible.

5. Only available to City of Longmont water customers.
6. New construction and major renovation projects are not eligible for toilet or urinal rebates.

Incentive details and requirements:

- Electric efficiency incentives are available to commercial electric customers of Estes Park Power and Communications, Fort Collins Utilities, Longmont Power & Communications or Loveland Water and Power
- Water efficiency incentives are available to commercial water customers of Fort Collins Utilities, City of Longmont or Loveland Water and Power
- Rebates are available for NEW equipment only. Used or refurbished equipment does not qualify.
- Total incentive amounts over \$10,000 require pre-approval before efficiency upgrades begin
- Total incentives are limited to 100% of a project total upgrade cost
- Water incentives are subject to a \$5,000 cap.
- Water incentives must be submitted by December 31, 2025. Any water incentives submitted after December 31, 2025 will not be eligible for incentives through Efficiency Works.
- Efficiency Works Business maximum incentive limits will apply per project, see Program Guide for details
- Applications must be submitted within 45 days of purchase or project completion.
- Proof of purchase required. Proof of purchase, or other supporting documentation must include:
 - date of purchase, price paid, model information to verify eligibility and shipping information if applicable.
- Program reserves the right to verify installation of a rebated product.
- Efficiency Works reserves the right to discontinue or change rebates without official notice.
- For commercial customers – total incentive amounts over \$10,000 require pre-approval and will be processed through the Efficiency Works Business rebate program. Learn more and apply at <https://efficiencyworks.org/business/rebates/>
- Multifamily properties with five (5) or more units per building and a commercial electric meter qualify for commercial rebates.
- Multifamily properties with fewer than five (5) units per building, or individual tenants, with a residential electric meter qualify for residential rebates.
