

Recycling rebate application instructions

Eligibility requirements for Efficiency Works rebate for refrigerator/freezer recycling:

- Electric customer of Estes Park Power and Communications, Fort Collins Utilities or Longmont Power & Communications.
- Appliance must be between 10 and 30 cubic feet and in working condition.


Prior to taking your appliance for recycling please:

1. Take a photo of the appliance*, and
2. Take a photo of the model number on the appliance*.

*Note: these will be required documentation, in addition to the recycling receipt, to be uploaded as part of the application.

4. Only eligible customers can participate. Enter in the name and address information associated with your utility account, in addition to selecting your electric and water utility. We will verify you have an electric account on the back end when processing the application. If you would like

your rebate check to go to a different mailing address, please enter that on this page as well. To proceed to the next page, please select the > button.

5. On the next page, continue to enter in applicable information. For the date, please enter the date you took the appliance to be recycled. **Please make sure to check the box next to “Please check this box if you were instructed by Efficiency Works to claim a recycling rebate.”** To proceed to the next page, please select the > button.
6. On the next page, please select the check box next to “Refrigerator Recycling”
